- 1. Bidders are requested to fill up the Registration Form Completely and attach the same with EMD (Earnest Money Deposit) at the auctioneer's/seller's address before the last date along with the self-attested copies of the required documents.
- 2. - 5. Bidders (H 1, H2 & H3) bid should be valid for 20 days in Part B and for 3 months from date of conveying approval in respect of part A of the tender.
- 6. Seller does not give warranty or guarantee of the quality, quantity, measurement, condition Chemical composition of each individual item/s or lot/s that form the auction / tender property and about its "End Use" or fitness for a particular purpose. - 7. The highest bidder/offer does not get any right to demand acceptance of his offer. - 10. In the event of failure on the part of the successful bidder to fulfill his contractual obligations, seller reserves the right to debar such bidder from participating in any future auction conducted on behalf of seller.
- 11. In addition, EMD must be 10% of the total salvage value and EMD we asked here is only the security money to participate. So highest bidder is requested to

- 12. The bidder shall have no right to withdraw, modify or question the sale after submitting a bid, by reason of any mis-description, error, defect or any other reason whatsoever.
